Utilizing a district Culture and Climate coach, seven teachers worked together to plan five Collaborative Thursday sessions designed to build student self-management and self-awareness. Teachers were asked to gather data about student self-awareness by taking a survey. This data was used to open discussions and guide further Collaborative Thursday sessions throughout the year. The final session took a focus on teacher goals for the final two months of the school year. These sessions furthered the conversations about Social Emotional Learning on campus.

Money had been set aside for pull out training and planning sessions, this did not take place. Money was set aside to compensate teachers for their after school planning sessions, this did not occur.
